The house that Martin built The building of Glenn Parochial House By J. J. Sands

IN THE summer of 1848 the valley from Poyntzpass to Newry was quite literally 'a hive of activity' as hundreds and hundreds of workers laboured to complete the last stages of the rail link between Belfast and Dublin.

But other things were happening too. On 1st September of that year Rev. Dr. Michael Blake, Bishop of Dromore made his annual visitation to the Parish of Donaghmore. Dr. Michael Blake appears to have been a stern, autocratic man. It is customary to think of the Irish peasantry of the period as being in awe of the clergy and indeed many may well have been but not all. On one occasion earlier Dr. Blake had received a very cold reception from his flock in Rathfriland and as events were to prove in Donaghmore, many people were not afraid to oppose his instructions. However, his parish clergy appear to have been truly in awe of him and ready to carry out his instructions to the letter.

Anyhow on September 1st, 1848 Bishop Blake left instructions, that a new parochial house was to be built at Glenn. There was no argument with this dictatorial command, no board of Governors, no committee to challenge his wishes.


The parish priest at that time was a father Martin Ryan, a Tipperary man, and his curate was Fr. Francis Blake (I have not been able to establish whether or not the Curate was related to the Bishop). It fell on Fr. Ryan to carry out the Bishop's order to build the new parochial house for the parish of Donaghmore. There were two catholic churches then, as now, in the parish, one at Barr where the present church still stands and the other only a short distance from the present site of Glenn Chapel. Fr. Martin Ryan decided to build the new parochial house just beside the old Glenn Chapel in ground that was leased from the Innes family of Dromantine.

Those readers familiar with the area may well remember a two-storey house in the grounds of Glenn Chapel, for it was only demolished some ten years ago by the present parish priest, Fr. Treanor when he was responsible for major renovations to the Church and the surrounding grounds. Well, that large two-storey house, now demolished was 'The House that Martin (Ryan) built' between 1848 and 1850.

I have to say right away that the project was not popular with the parishioners who, of course, had to

provide the greater part of the funds needed. There were several reasons for this. (1) The last days of the disastrous famine were being played out on a disspirited and poverty-stricken people, and while the junction railway had provided welcome work, as it ran through the townland of Knockanarney, in the parish, the prospect of the extra burden of contributions towards the new house caused widespread dismay. The Catholic parish of Donaghmore consisted of 223 families, many of them living in very poor houses where real poverty and hardships were endemic. (2) There was a small school beside the old chapel, and it was to be knocked down to make room for the parochial house. As a result, children from Glenn would now have to make their way to Derrycraw School, on the Newry to Loughbrickland Road a distance of nearly three miles. (3) Many parishioners thought that they ground around the chapel should be used as a graveyard. At that time, and for hundreds of years prior to that, all Catholics had been buried in Donaghmore Church of Ireland cemetry. I know this particularly as a plot "The burial ground of the Sands family' remains there..A rather bizarre incident had occurred some months before in December 1847. On the 3rd of that month, a Michael Grimes of Ballyblaugh had with others, dug a grave and buried his deceased sister in the grounds of Glenn Chapel. Fr Ryan called an immediate meeting in the Chapel to deal with the matter. I should say at this point, that Fr. Ryan was the most methodical administrator I have ever come across. He kept minute records of all his affairs.

At that time the avenue from Dromantine was through what is called the 'Dark Walk' with the exit directly, opposite Glenn Chapel. Now if Fr. Ryan was in awe of the Bishop, he appears to have been absoluately terrified of her ladyship, Mrs. Innes. "At the meeting in the 3rd December 1847", according to the minutes, "Fr. M. Ryan arose and addressed the meeting at considerable length, His vindication of his own conduct in remonstrating against the interment which they were assembled to complain of arising, as it most certainly did, from a sense of duty imposed on him by his, and their, venerated superior The Right Reverend Dr. Blake, and his justified action of the reasonableness of the motives which influenced that much respected proprietor of Dromantine Demesne, Mrs. Innes, to prohibit interment of the dead in the

Glenn Chapel Yard, as offensive to her own and her family's feelings, were received with the utmost satisfaction...'

"......He was sure that their regard for the refined sensibilities of the Upper Classes of Society and their reverence for the authority which interposed in the present instance to enforce respect for their feelings, would prevail to induce the relations of the deceased to exhume her remains and transfer them elsewhere. The motion was carried unanimously. James Rice (Chairman); Martin Ryan (Secretary)."

So the deceased was duly exhumed and buried in Donaghmore, as Mrs. Innes was opposed to having an unsightly graveyard at her entrance - although it was a considerable distance from Dromantine House itself.

For all of these reasons the building of a new parochial house was to be controversial. However on 8th September, 1848, exactly one week after Bishop Blake issued his command, work commenced on the site of the new house. As I have said, Fr. Ryan kept minute records. He wrote:

"8th September, 1848. In compliance with the instructions of the Right Revd. Doctor Blake Bishop of Dromore, issued at a public meeting of the Glenn Chapel congregation on the Sunday previous to this day, the following persons assembled at an early hour in the morning to remove the school house; Patrick O'Hare, Edward Carroll, Pat Maccan, John Kenny Pat Hays, John Hays, Michael and James Malone; John Malone, Snr; John Malone Jnr; Felix O'Hare, Michael O'Hare, Arthur O'Hare, John Sands, Edward Digney, John Digney, James Digney, Pat Murphy, Hugh O'Hagan, Snr; Hugh O'Hagan, Jnr; Owen McAtamney, Snr; John McAtamney, Owen McAtamney, Jnr; Pat McAtamney, William McAtamney, Jnr; Fourtown. Michael Hoey, Oliver Hoey, Francis Hoey, Joseph Toole, Donaghmore; Patrick Grant, Domantine; John Murta, James Hannaway, Ballylough and etc. etc....'

"..... of the foregoing the following took one shilling each, their day's hire:- Felix O'Hare, Joseph Toole, Thomas O'Hare, John Digney Jas. O'Hare, Arth O'Hare, Hugh O'Hagan, Edward Carroll and James Hannaway 0/6, Total 8/6. 40Ibs of meal for breakfast for the entire......5 shillings, 5 pence. ½ gallon whiskey 4/0 and ½ gallon cordial 4/0-....8.0."


Each day thereafter Fr. Ryan kept a most exact account of his expenditure and of course of his income too, for without the latter, work could not go ahead.

The necessary funds to build the house, were to be raised by two collections (instalments) and. Fr Ryan devised a system of recording contributions which was most exactly followed. He wrote....'A correct account of the money supplied by the members of the Barr and Glenn Chapel congregations towards the erection of Donaghmore Parochial House, which commenced in 3rd October, 1848...'

"... The pecuniary assistance from the foresaid congregations was advanced in two intalments. The first instalment from the people of Barr was advanced on the Sundays included within 15th October till the 19th November, 1848; an that of the congregation of Glenn Chapel on the sundays occurring from 26th November, 1848 'till the 7th January 1849 when the collections were discontinued in the respective chapels. The contributors whose names appear in the following account at a date later than that above mentioned were either of the party opposed to the erection of the parochial house or deeply sympathised with them. The second instalment was advanced simultaneously on the Sundays occurring from 3rd March till 5th May, 1850. The following pages will furnish a copious detail of the receipts and expenditure.

Fr Ryan wrote that the account would be 'copious' and copious it certainly was. Every half penny is accounted for, every nail is paid for.

Fr. Ryan wrote down the names of every one of the 223 Catholic householders in the parish of Donaghmore, townland by townland — whether they contributed or not — and from this we have a very exact account of the names of the householders in Donaghmore in 1848 — an account which would other-

(Ballyblaugh); Thos Rice, Snr; Thos Rice, Jnr; Mark Burns, John Burns, James O'Hare, Thos O'Hare; Michael O'Hare, Pat O'Hare (Dominick); Pat Murphy, Derryore; Michael Fitzpatrick, John Fitzpatrick, wise be unavailable as census returns for that period have been lost.

The extent of the opposition to this venture or the inability of the people to support it may be gauged from the fact, that only 97 families out of the 223 were able or willing to contribute to the 1st collection or as Fr. Ryan puts it "co-operate with me in raising the parochial house." The second collection was marginally better supported, with 105 householders contributing.

This poor response meant that the total collected in the two chapels amounted to only £84-1s-7d which was far below what would be required even in 1848. Fr. Ryan set about fund raising elsewhere outside the parish. He himself contributed £20 and the Bishop who had ordered the building donated £5. Mrs. Innes gave £1.

The opposition to the building of the house appears to have continued throughout 1849 and into 1850 and, apart from refusing to contribute towards the project, some elements in the congregation appear to have actively undone the building work on occasion. Such was the frequency of these noctural visits to the site, by individuals who knocked down what was built during the day, that Fr. Ryan had to hire watchmen to guard the work. This was an added expense he could well have done without.

The ill-feeling appears to have been such that sommonses were issued against some locals, for 20 summonses were served by Mr. Pierce on 8th December, 1848 at a cost of 5/=. There is also a local tradition that so pressed was he for support among his own congregation that members of the 'watch' had to be recruited from other denominations and indeed from the Orange Order.

An unusual 'fund raising' event organised by Fr. Ryan, was a 'Charity Sermon' in Barr Chapel.

On 2nd February, 1849 Fr. Ryan wrote "on this day our funds were exhausted, the treasurer Mr. Thos. Rice, Derrycra, having returned from Newry with only 2s. in his purse."

Thereafter he records "Commissioned to erect this house, I supplied, out of my Christmas dues, as far as they went, until I would be relieved by the proceeds of the Charity Sermon to be preached in the Barr Chapel by the Revd. Daniel Sharkey PP, Ballynahinch on 25th February, 1849. I ordered an issue of placards announcing the sermon and tickets of invitation to it. They were supplied by Mr. Collins, Hill Street, Newry and the surrounding country for several miles were by placards posted up in public places advertised the intended sermon."

The accounts were signed on 2nd February, 1849 "on behalf of the committee" by Thomas Rice, Bernard Books, Patrick O'Hare, James Blaney and Michael Fitzpatrick.

The Charity Sermon proved to be quite successful in that it raised £69-17-00, not far short of the total contributed by the combined congregations earlier but it still left Fr. Ryan a long way short of the total required. Bills kept coming in and it appears that in order to complete the work, he was forced to go round the countryside seeking contributions from all and sundry. He carefully recorded every donation, including those from "the tradesmen and labourers" of the Junction Railway, "who most generously donated from 1 shilling to 6 pence each."

Eventually by November, 1850 the work was completed and almost paid for. Any thoughts Fr. Ryan might have had of a quiet time were dispelled when he was immediately transferred from the Parish of Donaghmore — no doubt to end the ongoing controversy over building the house. He records that the balance of 14/4 owing to Mr. Carvill of Newry "will be immediately effaced" on the return of some planks still at the site.

In all "The house that Martin built" had cost $\pounds 221-12s-19\frac{1}{2}d$.




